### 4. FIRST AID MEASURES

**Eye** Wash eye thoroughly with running water for at least 15 minutes and seek medical attention.

**Swallowed** Seek medical attention following accidental ingestion.

**Skin** Wash area immediately with water.

**Aggravated Medical Conditions**

- Individuals with hypersensitivity to tramadol hydrochloride or any excipients
- Acute intoxication with alcohol, hypnotics, analgesics, opioids or psychotropic drugs
- Patients who are receiving MAO inhibitors or who have taken them within the last 14 days
- Individuals with sensitivity to opioids
- Individuals at risk of respiratory depression
- Individuals with epilepsy or those susceptible to seizures

**Advice to Doctor** If large volumes of solution have been swallowed the patient should be observed for signs of respiratory depression for at least 2 hours.

Naloxone will reverse respiratory depression, but not all symptoms caused by over dosage with tramadol hydrochloride. Adequate ventilation should be maintained. Haemodialysis is not expected to be helpful because it removes only a small percentage of the administered dose. Convulsions occurring in mice following the administration of toxic doses of tramadol hydrochloride could be suppressed with barbiturates or benzodiazepines, but were increased with Naloxone. Naloxone did not change the lethality of an overdose in mice.

Serious anaphylactoid reaction may require treatment with adrenaline, oxygen, intravenous steroids and airway management including intubation.
